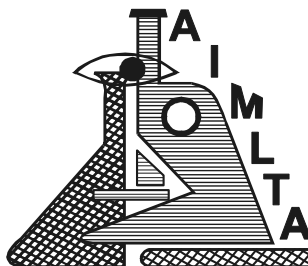

PROCEEDING OF CENTRAL EXECUTIVE COMMITTEE AND STATE SECRETARIES MEETING OF AIMLTA HELD IN THE PREMISES OF (LECTURER HALL NO. 1) ALL INDIA INSTITUTE OF MEDICAL SCIENCES, ANSARI NAGAR, NEW DELHI - 110029, INDIA

DATED 28th December, 2014

- 1. Inaugural and Welcome address by the President, AIMLTA** — Central Executive Committee and State Secretaries meeting of AIMLTA started as per scheduled programme on 28th December 2014 at 11.30 A.M. sharp in Lecturer Hall No. 1 of AIIMS, New Delhi under the presidentship of Mr. Dhananjay Kumar, President, AIMLTA. While inaugurating the C.E.C. meeting, President cordially welcome all the C.E.C. members, State Secretaries, Members of Academic Board and Spl. Invitees and requested them to extend their full cooperation to strengthen the association for all round development of Medical Lab. Technologists of India. He emphasized to chalk-out future programme such as result oriented organizational network programme, Training and Education in Med. Lab. Technology to members, and given very prospective views and expressed his good wishes to all participating members and requested Mr. A.N. Sinha, General Secretary AIMLTA, to proceed with C.E.C. meeting agenda.
- 2. Confirmation of last C.E.C. Meeting [at HUDCO ISPAT Club, Bhilai, Chhattisgarh] on 8th & 9th Feb., 2014** :— As per agenda Mr. A.N. Sinha, G.S. AIMLTA, read out the proceeding of Bhilai C.E.C. Meeting (8th & 9th Feb. 2014) and provided printed copy of the same to all participants which was confirmed by voice vote, after full length discussion.

General Secretary Report, Discussion & Member Opinion :

Mr. A.N. Sinha, General Secretary, AIMLTA presented his report before the CEC and provided printed copy of the same to all participants and association activities, produced below :-

It gives me immense pleasure and privilege to present before you my report as General Secretary, AIMLTA, which will reflect all round development of the association towards fulfillment of its main objective at national level.

This time I feel proud to organize the C.E.C. meeting in New Delhi with active support of Mr. Surydeo, State Secretary, Delhi State Unit and Mr. Sawinder Masih newly co-opted CEC Member, Delhi. In this meeting we will discuss various issues including most important issue **"THE FORMATION OF COUNCIL FOR MEDICAL LAB. TECHNOLOGIST OF INDIA"**. Council has been delayed and kept in cold storage by the out going Central Govt. Now new progressive govt. has come up and we have to make sincere efforts to see that Council Bill is passed in the Parliament. I have submitted a memoranda to respected Shree J.P. Nadda, Hon'ble Union Minister of Health & Family welfare, Govt. of India, Copy inclosed.

Before highlighting the activities of the association I would like to give brief history of the association along with its aim and objective so that Med. Lab. Technologist as well as Central Govt. could know the association (AIMLTA) in better way.

A body of Medical Laboratory Technologists came into existence in the State of West Bengal in the year 1970-71 and developed to National Body as All India Medical Laboratory Technologists Association (AIMLTA) and registered under Society Registration Act, 1860 at New Delhi in the year 1981 and the Registration No. S/12081. The association has assumed National character and constituted state unit in almost all the state and the union territory of the country.

Due to advancement of Medical Laboratory Technology in India and abroad and globalization of Medical Technology the Association inter into international arena and affiliated to International Association of Medical Laboratory Technologist (IAMLT) Thun, Switzerland subsequently to IFBLS, Canada (International Federation of Bio-medical Laboratory Sciences) and became the active member of Asian Association of Medical Laboratory Scientists (AAMLS) Japan. The association is also N.G.O. members of World Health Organisation (WHO) and making all round efforts to streamline the Medical Laboratory Technology and its quality Control for better Primary Health Care system in the country.

Now AIMLTA is a professional association and an "Apex Body" of Medical Lab. Technologists of India which is working hard in the best interest of Medical Lab. Technology and technologists of India. Our main object is to foster cooperation and mutual assistance among Med. Lab. Technologists for all round development of their socio-economy and academic status in Medical and Health services and proper recognition of this profession through "Statutory Body" i.e. Council for Medical Lab. Technologists. This association excludes from its programme all political and religious activities and undertake various social welfare health programme to serve the poor section of society by and large and coordinate with National and International agencies which are working in Lab. Medicine field with its objective **"Health for all"**.

Association network wing is spread up right from Kashmir to Kanya Kumari and state units have been established in all most all states of the country.

According to recent data available with the association the total strength of Medical Lab. Technologists in India is about 5.10 lacs (Five lacs ten thousand) working in Govt., Semi Govt., Public and Private Sectors and association is persuading them to join this professional association for their bright future and right placement in medical profession. Up till now (from 1971 to November 2014) more than 36000 (Thirty six thousand) Med. Lab. Tech. have been registered as member of the AIMLTA out of which total strength of life member including student member is 24800 (Twenty four

thousand eight hundred). The most important development in recent days is NRI Medical Lab. Technologists attraction towards AIMLTA. Large No. of NRI and Med. Lab. Technologists working out side country are registering their name as Life member of AIMLTA such membership on-line registration is increasing day by day. Member from UAE, KSA, Katar, Nepal, UK, USA, Sri Lanka, Bangladesh, Canada, Bhutan, Behrain, Kuwait are seeking information for membership on our web-site exceeding more than 1050 (one thousand fifty) & more than 721 (seven hundred twenty one) registered which is remarkable achievement for AIMLTA. Though membership drive is progressing well even than more efforts should be made to launch organizational network in uncovered area. Only by majority and unity we can secure right place in Medical professional's societies by developing our social technical academic and economic status. For all these prospect. AIMLTA has submitted a National Policy Draft (NPD) to the Union Ministry of Health and F.W., Govt. of India and also to different state govt. Health Ministry for maintaining uniformity with regard to recruitment promotion, pay structure, job description, hazards risk allowance, non practicing allowance, training and job oriented refresher course, opening of MLT Training Inst. at National Level and many other social and technical programmes have been placed before the govt. for consideration.

We have also placed specific demand before the Union Health Ministry, Govt. of India for change of nomenclature of Lab. Technician as Medical Lab. Technologists and also to declare the post technical (Scientific).

Academic Activities of the Association : AIMLTA is dedicated and to Committed for the development of the MLT Training programme in the country and it has introduced various MLT training programme to produce skilled and technically qualified personnel in the field of Med. Lab. Technology to cope the growing demand of trained Med. Lab. Tech. in the fast growing Health Care System and National health programme of the country. Academic Board, AIMLTA is playing a key role in training programme and has introduced one year and Two years DMLT courses and PG DMLT for student members and in-service members through its recognized affiliated MLT training institutions in indifferent states of the country and every year 1000 to 1100 MLT trained personnel are passing out successfully to manage pathology labs in govt. and non-govt. organization. Apart from this short terms refresher course and CEP programme for the members of the association have also been introduced under Academic Board, AIMLTA. Under qualification expansion programme, members having one year diploma certificate in MLT has been awarded two years diploma in Med. Lab. Technology on merit basis such as proficiency exam and practical examination 2012. This training programme is very fruitful for medical lab. professionals.

For professional skill and for quality assurance, the association is also considering the vital aspects of Accreditation of Laboratory Functioning in India in accordance with W.H.O. programme, Union Ministry of Health and F.W. Govt. of India has offered and invited our association to start various Public Health Programme under Public Private partnership. Recently we have received a reminder and offer from Union Ministry of Health and F.W. Govt. of India for **P.P. Partnership** but association will participate in all these programme only after formation of council for Med. Lab. Technologist. Even then to serve and help the poor section of society, Association has organized various health camps (pathological investigation for Diagnostic Treatment) including Blood Donation Camp in different states and also organized scientific seminars and workshop for development of Med. Lab. Technology and Technologists of India. State units have been given matching grants from central fund for all such events. Bihar, Chandigarh, Gujarat, U.P., W.B., Karnataka, T.N., Delhi, M.P., Maharashtra have organised conference, S.Seminar and workshop in their respective state.

Publication of Chronicle : Chronicle (Regd. No. BIHENG/2006/17161, ISSN 2349-1302, SS Post No. PT-69/2014) is the most important and prestigious journal of the AIMLTA. Association has taken up the publication of Qr. Chronicle along with Annual issue at the time of A.I.C. & S.S. every year. Qr. Chronicle has been regularized and being released every Qr. in time and distributed to the members. Editor and Editorial Board AIMLTA is working hard to ensure timely and Quality publication of Scientific Journal.

Website : AIMLTA website www.aimlta.org with Internet Broad Brand facilities has been opened for fast communication through electronic media. All information and activities of Association and Academic Board, AIMLTA are being displayed on website www.aimlta.org and also International information of IFBLS and website has been updated after removing all technical problems.

This facility improved the popularity of AIMLTA in India as well out side India and many NRI Med. Lab. Technologists or those working out side India are approaching us for membership of AIMLTA. Association is taking proper care and action into the matter. Now we can enjoy the AIMLTA web site and can feel proud of its performance.

Academic Board has been reconstituted at Bhilai during CEC Meeting on 9th Feb. 2014.

AIMLTA amended constitution is for printing in printing press. Delayed in printing is regretted. Very soon it will be available to all state secretary, all CEC member and all ex-official of AIMLTA for their need full action. This time when we are in Delhi all efforts will be made for the purchase of flat at Delhi for the Registered Office of AIMLTA with the active support of State Secretary, AIMLTA, CEC Member Delhi and others.

It was notified to hold NRI Meet at AIIMS, New Delhi during 40th AIC and invitation has been given to NRI Members to join the AIMLTA Conference on 29th and 30th December 2014. Only 9 NRI members telephonically informed to join the said conference but non of them have sent their delegation fee.







Income Tax : We are filing income tax return every year. We have applied for the exemption for tax rebate but yet I.T. authority have not given the exemption in tax. Banks are deducting TDS as per rule.

State Activity Payments : We have paid to the state M.P., Tamil Nadu, West Bengal, Chandigarh, Bihar, U.P., Pudduchery previously. In this matter I would like to request the state Secretary. to submit their receipt and payment every year and ask for the State Activity Payment for routine activity and for Scientific Seminar AIMLTA giving ₹ 10,000/- as per help for the function rest of the amount state have to raise.

AIC & SS : Last 39th AIC & SS we organized at Kanyakumari and total expenditure was ₹ 21,37,568/- whereas we received ₹ 9,24,500/- only as delegation fee. Organising Committee could not collect the donation for AIC & SS as per the CEC decision. As such it is again suggested that state where All India Conference is organised should collect donation and generate the fund to 25% amount of total budget.


Receipt are well and good as per expectation but for the payment side we have to follow the financial discipline submitted for suggestion & discussion.

Dr. B. N. Shukla, Chairman, AB, AIMLTA presented his report before the C.E.C. and provided printed copy of the same to all participants and Academic Board, AIMLTA activities produced below :—

Now, It is my privilege rather duty to submit the annual Academic activities report and as well as the minutes of the Academic Board's meeting which was held on 13th and 14th of Oct., 2014 in the head office, Patna.

The report reckon with are as follow -

1. Examination : One year and First year (2 yrs Course) DMLT examinations in all the existing recognized Institutions/ colleges to the privileges of Academic Board AIMLTA in the country was conducted from 25th to 29th June, 2014 and the Final year (2 yrs course of study) and One year PG DMLT examination 25th to 29th Aug. 2014 as per scheduled academic programme fixed by AB, AIMLTA. No unfair and unhealthy atmosphere had been noticed during the entire period of examinations and conducted in all the centres smoothly under the provisions of AB, AIMLTA.

2. Appointed Examiners : A total of 37 (thirty seven) external examiners has been appointed by the controller of examinations as per requirement in accordance with the rules and regulations of the Board. In the events of an examiner, being unable from any cause of fulfill his duties, not accepted his appointment, the controller in an emergency has nominated and appointed as accessible substitute with immediate effect and reported to the Chairman, AB.

3. Observer : More so, to access the infrastructure of the Institutions, particularly their Lab. facilities, method of teaching, the standard of teachers and requisite books availability, three observers namely Mr. A.N. Sinha, Mr. Birendra Kumar and Chairman himself were vigilant in the prevalent centres in South India during the entire period of examinations and given them memoranda to uphold AB norms. The observers had also strove to procure new Institutions under the privileges of AB, AIMLTA and provisionally certified on Institute in Tamil Nadu.

4. Remuneration : TA/ DA and remuneration of the appointed examiners for conferring their duties in theory and practical examinations has already been paid either through Bank DD, Banker's cheque or cash and not a single bill for payment of any them is pending in AB office. Other than this, any kind of payment, connected with examination work has been paid to the concerning persons respectively.

5. TA/DA bill submission : The examiners are requested to mention actual Railway mileage in their bills, complete address with Pin Code (in Block letters) and phone number.

6. Registration Fee of the Student and other kind of Remuneration : Keeping in view the upsurging market prices consistently, the registration and examination fee of the Student is revised further in agreement with the directors of the institutions in the Director's meeting which was held at Chennai on 23rd of June 2014 at Royal Guest House, Chennai. The Registration fee of students for appearing in the examination:

REMUNERATION RELATED TO EXAMINATION WORK :

The sequence shows that apparently the institutes and their students in numbers are in increasing order from 2011 to 2014, while the member of PG-DMLT students are less in number in 2014, but I do hope in the forthcoming examination the number of institutes and students of all set of courses will be increased.

9. Relevant activities of Academic Board related to examination : Two sets of questions paper were set by the experts in respective disciplines of Med. Lab. Technology, reviewed, moderated and printed. The answer books were evaluated by well experienced eminent Med. Lab. Technologist and Technical teachers. The obtainable marks both in theory and practical was tabulated, configured in the office of the controller of exams, kept confidential, while in the annual meeting of AB, AIMLTA, the figure & facts was explained by the controller of Exams for confirmation, finalisation and preparation of progress card. The results has already been declared in website and progress card and Diploma certificates dispatched in the respective Institution/colleges. The assessment of evaluator and external examiners was considered and kept final and no changes in obtainable marks of the students had been done in the office of controller of examinations.

10. Syllabus : Minor changes in the course content of 2 yrs DMLT has been done as it was suggested and approved by CEC and made available to the Institutions. This syllabus will be applicable from the session 2015-2016. The syllabus is also incorporated in website.

11. Renewal Fee : The dues are recovered from the institution towards their validation under the provision of AB, AIMLTA.

12. Continuing Education Programme : The CEP merit certificate along with grade mark-sheet for the session Dec. 2013 has been dispatched to the secretaries of the state concerned with it after confirmation in the annual meeting of AB, AIMLTA, 2014. A total membership of participant were 69 (+2 subt. Late) of which from UP (25), New Delhi (2), Gwalior (26), Indore (15), Rajasthan (1) and from Bhopal (2 submitting late) and all were successfully completed by obtaining respective grade A, B, C. The question Booklet for the session Dec. 2014 is dispatched to the state secretaries for their participants.

13. The tenure of AB Office : The tenure of AB office may be amended and extended as proposed by AB members in the annual meeting of Academic Board (21st & 22nd Sept. 2013) and further it has been asked to be considered in its meeting which was held on 13th & 14th Oct. 2014 at Patna, keeping in view that the tenure of Association's office is amended, reconstituted and resolved for three year instead of two years. Hence, Academic Board shall hold the office for five years instead of three years from the date of the reconstitution or the date of notification by General Secretary, the executive head of AIMLTA. Hence, it is a request that the aforesaid amendment shall be made as early as possible.

In spite of our current difficulties with the states we are striving for lasting institution to the privileges of AB, AIMLTA to attain better future of it. Nothing can be attained without effort. The greater the effort, greater the possibility of attainment.

C.E.C. discussed on chairman, A.B., AIMLTA report and approved all the suggestion from Sl. No. 01 to 12 as mentioned in the report under reference, except suggestion no. 13 i.e. extension of tenure of A.B., AIMLTA which has not be accepted. There will be no change in the tenure of A.B., AIMLTA for the present.






